- 2. ONLINE & OFFICE ENTRIES CLOSE FRIDAY 2nd May 2025
- 3. PAYMENT MUST BE MADE ON SUBMISSION OF ENTRY. NO PAYMENT, NO ENTRY
- 4. LATE ENTRIES WILL BE ACCEPTED UP TO THE 4^{TH of} MAY AND WILL INCURR A \$30 FEE TO BE PAID WITH ENTRY AND WILL NOT BE INCLUDED IN THE CATALOGUE.
- 5. Prizes are 1st place \$30; 2nd place \$25, 3rd place \$20 in every class

- 7. No Cattle to leave the grounds before 2.30pm on Friday 16th May 2025

JUDGING

- 1. Interbreed Judging commences at 8am Friday 16th May 2025
- 2. Junior Judging and Judges Paraders will take place after interbreed judging on Friday.

GENERAL

- 1. All Cattle are to be free of ticks. Cattle will be randomly inspected for the presence of live ticks.
- 2. Due to 'Workplace Health and Safety' all electrical leads and milking machines must be tested and tagged by a qualified electrician before bringing into the Showgrounds
- 3. No Dairy Cattle allowed on grounds prior to Tuesday 13th May 2025.
- 4. All cattle must be in their allocated stalls no later than 5pm Wednesday 14th May 2025 to allow for NLIS Scanning. Any Exhibitors unable to meet this deadline are to advise the Show Society Office no less than 24 hours prior to this time so that alternative arrangements can be made (which may incur an additional fee).
- 5. The Owner or Exhibitor of their respective cattle are responsible for the notification to the NLIS database of their removal from the Showgrounds within 48 hours of doing so.
- 6. If cattle arrive prior to Tuesday, it is the responsibility of the Exhibitor to dispose of waste.
- 7. All Exhibitors must be entered or eligible for entry in their respective herd books. Tattoo and herd book numbers to be inserted on entry forms. All cattle must be bona fide property of the Exhibitor. All cattle entered must have full names and birth date on the entry form. For Office purposes, a separate form for each breed would be appreciated.
- 8. Dairy classes in which age of exhibit is a condition of competition, the entry form shall state the actual date of birth (month and year). Age of classification will be 1st April of the current year.
- 9. Closing date for application for entry to exhibit the Gympie District Show is 4pm Friday 2nd May 2025. Late entries will be accepted up to Friday 9th May but will incur a late fee of \$30 and your entry will not be in the catalogue.
- 10. All cattle to be ready when classes are called. Classes will not wait for Exhibitors, once called.
- 11. Animals may be spot checked for tampering.
- 12. Stewards reserve the right to ask for cows to be 'milked out' under supervision. Clipping to cease at 9pm and not start again until 6am.
- 13. Please bring own feed bins.
- 14. If any animal falls ill and is treated on site, the Exhibitor will be responsible to clean up. The area must be cleaned up and disinfected immediately after use by the Exhibitor.
- 15. No animal shall compete in a Special Group Class unless it competes in one of the General Classes.
- 16. A Steward must be present during any administration of drugs to any animal.
- 17. Any cow or heifer in Dry Classes will be transferred to the 'In Milk' Classes should she calve between the date of entry and Judging day, and vice versa.
- 18. All cows in Dry Classes must be six (6) months in calf or dry (to be milked out on Judging morning if not completely dry).
- 19. No cattle will be admitted to grounds unless thoroughly tractable and must tie and lead.
- 20. Stewards have the right to refuse entry of any exhibit in any class.
- 21. Registration Certificate of all animals must be available if requested.
- 22. No dispute will be considered whilst event is in progress. Protests are to be lodged within one (1) hour of completion of event and handed to the Administrator accompanied by a fee of \$50.00. The Dispute Committee will consist of the following members: any three (3) members to act: R Zerner, T Moxey, S English, F Boyd.
- 23. All cattle, when judged, must have a catalogue number attached. This also includes the Supreme Judging.
- 24. All cattle must be accompanied by a valid Waybill (latest edition NVD preferred).
- 25. Footwear must be worn by the leaders in the Grand Parade.

- 26. Judges have the right to order any cow competing for Championship to be milked out before final awarding of prize.
- 27. Where there is only one exhibit, The Judge may award a second or third prize instead of a first prize, or may withhold a prize altogether, at his/her discretion.
- 28. The Steward in charge will advise position to park. Showers available on grounds.
- 29. Trucks must leave loading ramp immediately after unloading. At conclusion of the Show, cattle must be tied near ramp, ready to load before trucks are backed to ramp. Please state registration number on the entry form.
- 30. No loud music after 9pm.
- 31. NO ALCOHOL IN THE SHOW RING
- 32. SUBSTITUTION 3 ONLY PER EXHIBITOR THE SUBSTITUTION IN THE SAME CLASS AS THE COW WITHDRAWN

HEALTH REGULATIONS FOR ALL CATTLE ENTERING THE SHOWGROUNDS

BRUCELLOSIS

From herds classified as "Tested Negative" (TN), 'Confirmed Free' (CF) or 'Monitored Negative' (MN). No test required.

From herds classified as 'Provisional Clear' (PC), 'Non - Assessed' (NA), 'Infected' (IN), 'Suspect' (SU) or 'Restricted' (RD). NO ENTRY.

TUBERCULOSIS

From herds classified as 'Tested Negative' (TN), 'Confirmed Free' (CF) or 'Monitored Negative' (MN). No test required.

From herds classified as 'Provisional Clear' (PC), 'Non – Assessed' (NA), 'Infected' (IN), 'Suspect' (SU), or 'Restricted' (RD). NO ENTRY

- 1. ALL CATTLE MUST BE FREE OF TICKS
- 2. Cattle may be refused entry or asked to leave the grounds if they do not comply with above mentioned requirements.
- 3. Spraying of cattle to go back to clean area.
- 4. The Society will provide a sprayer and dip, but the owner is responsible for having the correct paperwork to have the job done.

CATTLE AGE

Cattle age is at the 1st April 2025

OLD YOUNG JUDGES AND PARADERS COMPETITION

YOUNG JUDGES: 15 years of age and under 25 years as at the 1st May

YOUNG PARADERS: Under 8 years not judged. Under 15 years, 15 to 20 years, 20 to 25 years

- 1. Competitors under the age of 18 years must have the approval of a parent or guardian to compete and the appropriate waiver signed on the **entry form**.
- 2. Competitors must meet one of the following criteria -
 - (a) A Queensland resident for a minimum of three (3) months prior to competing;
 - (b) Attend a Queensland educational institution;
 - (c) Residing interstate but can prove a connection with a Queensland Agricultural Society and satisfy one of the following criteria:
 - (1) Permanent address has a Queensland postcode;
 - (2) Competitor or parents are active working members of that Agricultural Society.

HOW TO PLACE AN ENTRY ON SHOWDAY ONLINE

REGISTER

- 1. When visiting Showday online for the first time you will need to create an account. Single click the **Register** button. Complete your details and then single click the green **Create New Account** button.
- 2. You will need to have the correct punctuation, address info etc, as this information is how all the shows you enter (via Showday.online) will identify you. An individual show cannot change this information once they have received your entry and you are responsible to keep this information up to date on Showday.online.
- 3. You will receive a welcome email from Showday.online. Follow the directions and setup your Showday.online login password. Then single click the green **Save** button. If you do not receive this email, please contact Showday.online via their **Contact** link.
- 4. YOU MUST DO THIS TO ACTIVATE YOUR ACCOUNT
- 5. Please do not create multiple accounts on Showday.online as each show will have information against accounts already created.

LOG IN

- 1. When you are a 'returning user' you will login with your email address and password. If you have forgotten your password, please refer to the 'Reset your Password' option on the login screen.
- 2. Once logged in, if you need to update your contact details click on your name in the top right hand corner of the screen. Any email address changes will need to be made by Showday.online.

- 3. Camping permits will be sent to your email address upon allocation of a site and payment.
- 4. Receipt of this form and payment does not guarantee a camp will be made available.
- 5. Camping permits need to be displayed in a visible location on your camp.
- 6. Limited powered sites are available, and they are allocated on first in basis.
- 7. Onsite permanent showers and toilets are available for use and waste bins are provided for campers. Please always keep them clean and tidy. Cleaners and bin managers will be on site.
- 8. A camp warden will check the camp grounds for camping permits.
- 9. Failure to meet any of these conditions could result in eviction from the Showground.
